Section 2136

PURPOSE: To add a section to explain how to amend the Penal Code, to match the same sections in the Constitution and the By-laws of The Grand Chapter of Washington.

**TEXT OF REVISION:** 

## AMENDMENTS TO THE PENAL CODE

Section 2136. Procedure for Amending The Penal Code

- 1. The Penal Code may be amended or repealed at any Annual Session of the Grand Chapter in the following manner:
  - a. Any resolution to amend or repeal shall be presented in writing (see Appendix 7) and signed by at least one (1) member, not more than three (3) members of the Grand Chapter of Washington and shall set forth the entire section or sections to be amended or repealed.
  - b. Such resolution, to come before the Annual Session of the Grand Chapter, must be sent either via mail or to each member of the Jurisprudence Committee by the member submitting the resolution at least one hundred and twenty (120) days before the Annual Session of the Grand Chapter convenes.
  - The Jurisprudence Committee must return the resolution to the signer or signers, together with advice only regarding its legality, at least seventy-five (75) days before the Annual Session of the Grand Chapter convenes.
  - d. Such resolution, to come before the Annual Session of the Grand Chapter, must then be filed with the Grand Secretary at least sixty (60) days before the Annual Session of the Grand Chapter convenes.
  - e. The Grand Secretary shall, within fifteen (15) days thereafter, have such resolution printed and copies thereof mailed to each subordinate chapter.
  - f. Ail resolutions not so filed will not be considered at said Annual Session of the Grand Chapter. Such resolutions shall be referred to the Jurisprudence Committee for recommendation.
  - g. A majority vote of the members present shall be required to adopt the resolution.
  - h. Such amendment shall become effective after the close of the Annual Session of the Grand Chapter at which it is adopted.
- 2- Correction of misspelled words, point form, spacing, other printing errata, which does not change the intent of the body corrected, as well as changes in the Ritual approved at the General Grand Chapter Triennium, may be done by the Grand Secretary, with the assistance and approval of the Jurisprudence Committee without submitting individual resolutions to make said corrections.

  - d. Such resolution, to come before the Annual Session of the Grand Chapter, must then be filed with the Grand Secretary at least sixty (60) days before the Annual Session of the Grand Chapter convenes.
  - e. The Grand Secretary shall, within fifteen (15) days thereafter, have such resolution printed and copies thereof mailed to each subordinate chapter.
  - of. All resolutions not so filed will not be considered at said Annual Session of the Grand Chapter.

    Such resolutions shall be referred to the Jurisprudence Committee for recommendation.
    - g. A majority vote of the members present shall be required to adopt the resolution.
    - h. Such amendment shall become effective after the close of the Annual Session of the Grand Chapter at which it is adopted.
