ARTICLE VIII, FINANCES: REVENUE, INVESTMENTS, EXPENDITURES

Section 802. Dues, paragraph 3

**PURPOSE**: Each year the Grand Chapter falls short of funds to cover the Grand Chapter. Registration no longer covers the cost, and this fund would assist in covering the shortfall.

### **TEXT OF REVISION:**

3. For each member on the roll of the chapter, and in good standing on the preceding 31<sup>st</sup> day of March, the sum of Five Dollars and fifty cents (\$5.50) shall be paid to the Grand Chapter of Washington. This amount will increase by One Dollar (\$1.00) for each of the following years, 2026, 2027, 2028, and 2029, until the total sum of Nine Dollars and fifty cents (\$9.50) has been reached. Exceptions are: fifty (50) year members, members confined to institutions for mentally ill, members diagnosed with Alzheimer's or dementia who are residents in care centers or receiving twenty-four (24) hour home care, and members who are physically incapacitated.

### From this sum:

- One dollar (1.00) shall be placed in a separate fund to provide for equipment acquisition and maintenance, and protracted office expenses for the Grand Chapter office.
- b. One Dollar (1.00) for each of the following years, 2026, 2027, 2028, and 2029, is to be added to the original One Dollar (1.00) for a total of Five Dollars (5.00) and shall be placed in a separate fund to be known as the Grand Chapter Session Fund.
- c. Three Dollars and fifty cents (3.50) shall be paid to the General Fund for the operation and maintenance of Grand Chapter. (The fact that chapter dues are remitted for any indigent members or members in nursing homes other than those excepted above, shall not relieve the chapter from the obligation of paying per capita tax for such members).

# WHEN PRINTED IN THE NEXT REVISION WOULD READ: OF REVISION:

3. For each member on the roll of the chapter, and in good standing on the preceding 31<sup>st</sup> day of March, the sum of Five Dollars and fifty cents (\$5.50) shall be paid to the Grand Chapter of Washington. This amount will increase by One Dollar (\$1.00) for each of the following years, 2026, 2027, 2028, and 2029, until the total sum of Nine Dollars and fifty cents (\$9.50) has been reached.
